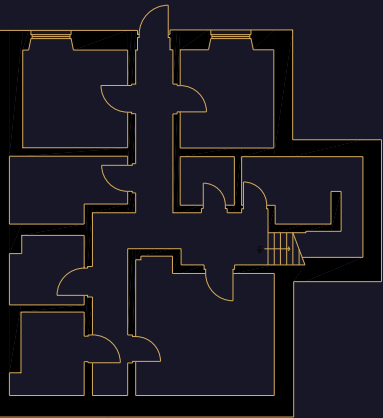
The premises is due to undergo refurbishment.

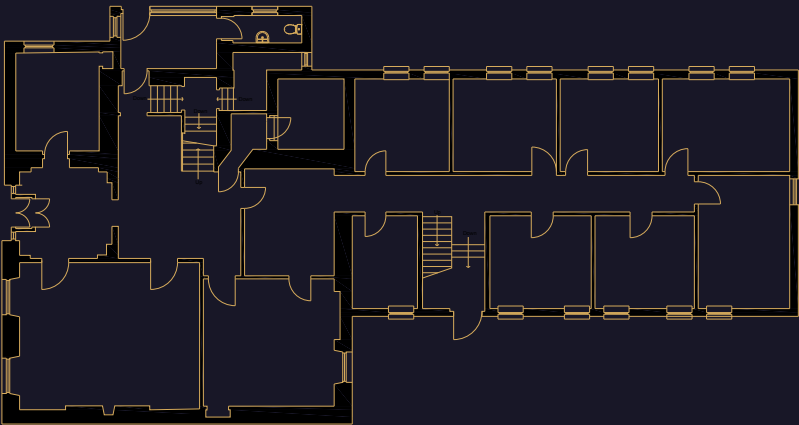

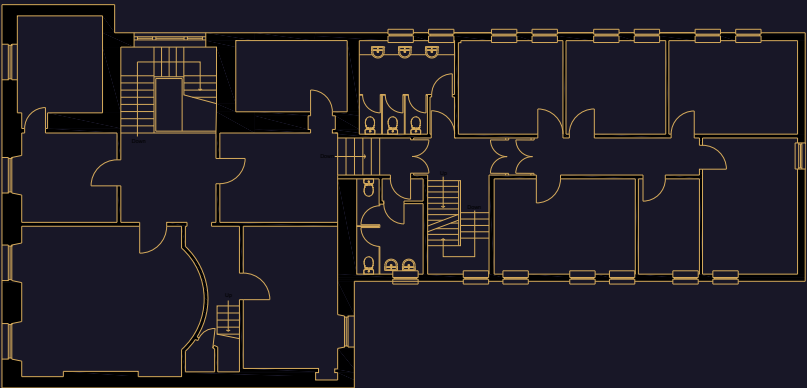
Layout Plans



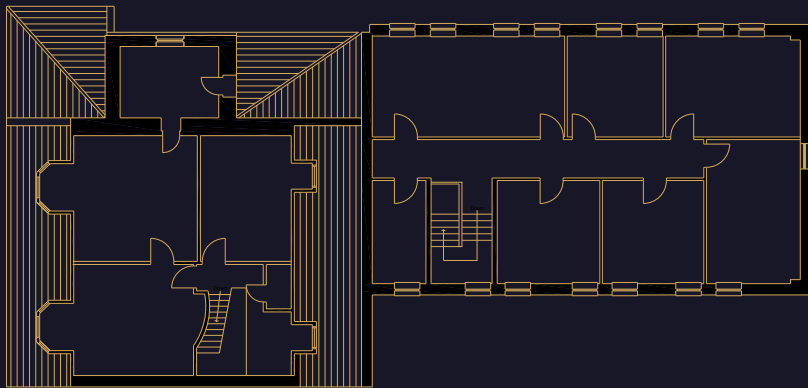
LOWER GROUND PLAN
